MINUTES of the MEETING of GORSEINON TOWN COUNCIL, held on WEDNESDAY 3 May 2023 at Ty Newydd Community Centre, 17 West St. GORSEINON, at 6pm

166. MAYORS ANNOUNCEMENTS. Clerk advised the Mayor had attended the following events

167.POLICE MEETING. The Police were represented at the meeting by PCSO Alison, and the following stats were given for month of April.

An assault incident on Sunday 30 April was reported and the offenders had been bailed and Prosecuted.

PCSO Alison advised that this would be her last meeting as she was transferring to Swansea Central to deal with ASB incidents for whole of Swansea. Members thanked her for her service over the last 7 years and wished her best for her future role. Members questions covered activities during Coronation, and Cllr J Curtice reported an incident with young 12 year old lad dumping his bike on pavement in High street and being abusive to her when challenged.

168. APPROVAL OF MINUTES

a. The Clerk presented the April 5th 2023 minutes (which had been distributed previously) for approval, and which were approved. (Proposed by J Curtice, sec Cllr A Thomas).
 Cllr Rawle asked for Min 159d to be amended to Swansea Pride, and she confirmed the Pride T shirts had been paid for by individual Councillors.

169.PUBLIC SESSION. No Members of the Public present.

170.MEMBER REPORTS on Local Matters from Town and County Councillors;

a. It was agreed only one County Cllr would report on County Council matters in future.

Cllr J Curtice reported on a very successful Brisco Fun run held on 30th April 2023, and it was hoped this would now be an annual event with the next one provisionally planned for May 17 2024. Chris Chapman was thanked for his extensive photo coverage, and an e mail to thank him was to be arranged. Car parking charge increases in Swansea were generating complaints, but she advised that permits were available for city residents and workers, with concessionary rates.

b. Cllr S Rawle

She outlined details of the Pride march in Swansea at the end of April which had been reported as a great success ,and very well organised. Council had also approved her attendance at the forthcoming LGBTQ+ conference in Cardiff in the summer to represent the Town Council.

- c. **Clir A Thomas** raised concern about the opening hours of the public toilets in the bus station. They should remain open until 6pm but were being closed at 3pm now. Clerk was asked to write to Parks dept to clarify the issue, and request they remain open until 6pm..
- d. Cllr M Curtice . asked that a future training session for defib. usage be arranged for the members of the Recycled teenagers club Mondays 11-1pm. Members asked for Clerk to provide a list of the installed defibrulators within the ward.

171. CLERKS REPORTS

- a) A request for **financial assistance** had been previously been received from the following. Members had agreed in Feb.2023 meeting that the grant allocation would remain in place and be distributed to worthy causes throughout the year as the Covid pandemic eased.
 - Requests received for April 2023 financial year 2023/4. Council approved the following;

It was agreed that a donation should be arranged for materials used in the Pop up café and other food services provided by members, as they shouldn't pay for the food themselves.. At the next meeting the actual details of an appropriate bank account would be provided.

- b. King Charles Coronation May 6 2023 was discussed. No additional action was planned. Appropriate flags had been erected within the Ty Newydd and War Memorial frontages.
- c. New Defibrulators on housing estate off Pontarddulais rd / "Well" chemists, Homebargains site had now been ordered, and would be installed shortly.
- d. Fresh Air Fitness equipment Parc Y Werin . Clerk had received quotes from **Freshair fitness** for repair and replacement works to the equipment in Parc Y Werin Gorseinon. Members had approved the quotes and asked the work be carried out as soon as possible. Work took place on March 22nd, but one item could not be repaired and a quote had been given for its replacement , which was approved. All new installations and servicing was done on site on April 24th. Cllr Thomas raised concern about flooding of the new playground area. Cllr J Curtice asked him to photo next incident so it could be shown to officer in parks dept for resolving.
- e. Clerk advised Council that the new **Active travel** route between Penllergaer and Gorseinon was now well underway, and was approaching completion over the next month, to provide a dedicated footpath/cycleroute between both communities. Many complaints had been received about the traffic delays being caused by the roadworks.
- f. Clerk advised he had sent email to West St Gym referring to complaints about on street parking by users of the Gym causing objections from local residents and asking that they use Lime st Carpark, as conditioned in their planning consent for use of the building. No reply had been received, and Clerk was asked to follow up with letter to the Club as the on street parking problems still continued

- a. One Voice Wales training courses were outlined for May/June 2023.
- b. Clerk reported notification from Welsh Govt that support for business rates grant would be increased in 2023/4 from 50% to 75%.. Clerk had applied and been successful in getting the reduction. Members had thanked the Clerk for securing the reduction.

174.ACCOUNTS

- a. Committee received the Income / Receipts summary statement from the Clerk and considered and approved the payment of the following outstanding cheques for the ACCOUNTS dated 3rd May 2023 (proposed M Curtice seconded J Curtice). After the meeting the cheques were signed by 2 authorised signatures having examined all relevant receipts. Clerk advised members on current Council spend against targets.
- b. Members noted that Clerk had submitted accounts to DCK Beavers for formalising for financial year 2022/23, and the final reports had been received from them. Audit submission was needed by start of June to Council Auditors. Members approved and Mayor signed the Annual Return for 2022/23 for submission to Auditors.
- c.Conclusion of 2021/22 Audit by Welsh Govt (year 1 of 3 year Welsh Audit GTC in year 1 was Noted. Report was awaited.
